

Manson Anchors USA Supreme Anchor Promotion

Terms and Conditions of Entry

1. Information on how to enter and prizes form part of these conditions of entry. Entry into the competition is deemed acceptance of these terms and conditions.
2. The promotion is open to United States of America residents 18 years and over. Employees of the Promoter and any agency involved with this promotion and the immediate families of such employees, are not eligible to enter. Immediate family includes the spouse, defacto spouse, child, parent, or sibling.
3. The promotion commences on Thursday April 29 2021 and closes on Thursday May 13 2021 ("Promotional Period").
4. To enter the promotion, during the Promotional Period an entrant must, fill out the entry form on the Manson Anchors website to sign up to the Manson Anchors marketing email database.
5. Any entry that does not meet the requirements of the above will be deemed ineligible.
6. This promotion is in no way sponsored, endorsed, or administered by, or associated with, Facebook or Instagram where it is advertised.
7. The winner will be determined by random result generator, which will take place Monday May 17 2021. In the event that an ineligible entry is selected, or the Promoter is unable to contact the provisional winner within 5 business days of the prize photo selection, having made reasonable attempts to do so, the Promoter may deem that winner's entry invalid and select a new winner on the same terms as the original photo prize selection.
8. The winner will be contacted by email address entered on the competition form.
9. The prizes are not transferable, changeable, or redeemable for cash.
10. There is one prize in total. The prize consists of one Galvanised Manson Supreme Anchor. The winner may choose the size of this anchor up to 60 lbs. The Anchors eligible are: Supreme Galvanized 10lb, Supreme Galvanized 15lb, Supreme Galvanized 25lb, Supreme Galvanized 35lb, Supreme Galvanized 45lb, Supreme Galvanized 60lb. Once awarded, the Promoter is not liable for any product that has been lost, stolen, damaged or tampered with in any way.
11. Neither the Promoter nor any other entity associated with this competition will be responsible for any late, lost, misdirected, corrupted, incomplete, or incorrectly submitted entries, including but not limited to entries not received due to technical problems or human error. The time entries are deemed to be made will be the time the entry is received, not the time the entry is submitted by an entrant.
12. The Promoter reserves the right to disallow entries in its absolute discretion and without giving reasons.
13. The Promoter reserves the right, at any time, to verify the validity of entries and determine the eligibility of entrants (including an entrant's identity and age) and to disqualify any entry or refuse to award a prize where false or misleading details have been given by an entrant, or where an entrant has behaved in a fraudulent or dishonest manner, or otherwise than in accordance with these terms and conditions or the spirit of the promotion.
14. The winners acknowledge and agree that he or she will comply with all instructions given by employees of the Promoter and other agencies associated with this promotion and agree not to do anything that may bring the Promoter into disrepute.

15. The winners agree that as a condition of receiving the prize, he or she may be required to execute a waiver and indemnity in the form provided by the Promoter.
16. If a winner cannot accept the prize for any reason, that prize will be void and no compensation will be payable.

Except for any liability that cannot be excluded by law, the Promoter (including its officers, directors, shareholders, employees, advisors, assignees, agents, licensees, representatives, advertising and promotional agencies), excludes all liability (including negligence), for any personal injury or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where attributable to any of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected ; (d) any variation in the prize; (e) any tax liability incurred by a claimant or entrant; or (f) use of a prize.

As a condition of participating in the promotion, the winners indemnify the Promoter, all organisers, sponsors and all other persons and organisations associated in any way with the promotion against all claims, damages, liabilities, costs, and expenses (including legal fees on a solicitor and client basis) which the winner may incur arising out of their participation in the promotion and/or using the prize, howsoever caused.
